- a) To establish a New Homoeopathic medical college-**Rupees Five Lakh only + 18% GST**;
- b) To open a new or higher course of study or training- **Rupees Two Lakh + 18% GST** per course/specialty.
- c) To increase admission capacity – **Rupees Four Lakhs + 18% GST** for undergraduate course and **Twenty-Five Thousand 18% GST** per seat for post graduate course
