Cancellation of Homoeopathy Education Board Letter F.no. 3-133/2023/NCH/HEB/DF-MF Hom./9285 Dated 13.2.2025 and submission of information in respect of recognition of M.F. (Hom.) Medical Qualification awarded by the Faculty of Homoeopathy, London, United Kingdom-reg.

Madam/ Sir,

With reference to the subject cited above, this is to inform you that the letter issued by the Homoeopathy Education Board (HEB), National Commission for Homoeopathy, with reference F.No. 3-133/2023/NCH/HEB/DF-MF Hom./9285, dated 13th February 2025, stands withdrawn.

- In this context, we draw your attention to the Ministry of Ayush Letter No. F. No. R.14015/01/1992-Homoeo( Part) dated 3.3.2020(copy attached), wherein it was decided that qualifications awarded on the basis of training conducted in India by the Hyderabad School of Homoeopathy & Institute for Clinical Research which is considered as not a recognized institute under NCH regulations moreover such a course run in India cannot be considered as eligible for recognition under Schedule -III of the HCC Act, 1973...
- In the light of above, it is requested that the application of Dr. Sudipta Sagar Biswas for registration with the Council of Homoeopathic Medicine, West Bengal, based on the aforementioned qualification MF (Hom.) run in India cannot be considered.

Please find enclosed herewith a representation dated 03.02.2020 received from Dr Sara Eames, Operation Manager, past President of Faculty of Homoeopathy on the subject cited above.

- In this regard, attention is drawn to Central Council of Homoeopathy's letter no. 14-6/2019-CCH/1742 dated 27.05.2019 (copy enclosed), wherein, the Council has recommended for not recognising such qualification granted on the basis of training conducted in India by the Faculty of Homoeopathy.
- Accordingly, vide/Ministry's letter of even number dated 23.08.2019 (copy enclosed) the Director, Hyderabad School of Homoeopathy & ICR, 8-3-945/A/22, Nagarjuna Nagar, Ameerpet, Hyderabad has been conveyed that the course run at Hyderabad in collaboration with MF (Hom), UK cannot be considered as eligible for recognition under Schedule -III of the HCC Act, 1973.
- In view of above, CCH is requested to examine the representation and take necessary action under intimation to the Ministry.

Sub: - Regarding Registration of MF(Hom) Degree denied by State Boards for qualified - reg-

Reference to your representation dated 8th April; 2019 received through Secretary to the Vice-President of India on the above cited subject, I am directed to inform that the matter has been examined in consultation with the Central Council of Homeopathy, a statutory body under the Ministry of AYUSH. It has been observed that Hyderabad School of Homoeopathy & ICR has been conducting the M.F.(Hom) Luton membership examination at Hyderabad and the said center has not been permitted by the Ministry of AYUSH or by CCH.

- 2. As per the provisions of HCC Act, 1973, the Central Council of Homoeopathy (CCH) was constituted to regulate the Homoeopathy education in the country. CCH has notified regulations for establishment of new Homoeopathy medical institutes and Minimum standards and requirements for the Homoeopathy institutes. Accordingly, all the Homoeopathy institutes established in India are required to comply with the provisions of HCC Act, 1973 and regulations made thereumeer.
- 3. In view of above, it is informed that the qualification of M.F(Fom) awarded by Faculty of Homoeopathy, Luton, United Kingdom, is included in the Third Schedule of HCC Act, 1973. However, the course run at Hyderabad in collaboration with MF(Hom), UK cannot be considered as eligible for recognition under Schedule-III of the HCC Act, as it is a course run in India without any consent of Ministry of AYUSH or CCH.
